



## **ENQUIRIES ABOUT RESULTS AND APPEALS – SUMMER 2022**

### **WHAT IF I'M NOT HAPPY WITH MY RESULTS?**

In the first instance, speak to your teacher or the exam officer.

They will have a look at your UMS score and check it against the exam board's UMS Grade Boundaries.

If your teacher advises a remark of your paper, the relevant fee must be paid to the school. There are three possible outcomes:

- Your original mark is lowered, so your final grade may be lower than the original grade you received.
- Your original mark is confirmed as correct, and there is no change to your grade.
- Your original mark is raised, so your final grade may be higher than the original grade you received. (Refund will be given as this was an error by the exam board)

If you decide to go ahead with the re-mark please complete the consent form attached and return it to Mrs Watkinson, **by 20<sup>th</sup> September 2022**. A copy of our Internal Appeals Procedure is available from Mrs Watkinson, Examinations Officer.
